TIMES OF SITTINGS

- The Court of Chief Pleas will take place on the 3rd October 2016.
- The Royal Court (Ordinary Court) (Jurats business) will sit at 10.15a.m. on the dates set out below.
- The Royal Court (Full Court) sits at 9.30am on the dates set out below save for 3rd October 2016 when it sits at 2.30pm.
- The Ordinary Court (Bailiff's business) will sit every Friday at 9.30am followed by Interlocutory business.
- The Royal Court Matrimonial Causes Division will sit unrobed at 10.15am on the dates set out below to consider all matrimonial matters (including judicial separation applications by consent).
- The Royal Court Criminal Division will sit robed at 2.30pm on the dates set out below for Plea and Directions Hearings. Counsel and defendants to be present at 2.15pm.
- The Royal Court Criminal Division will sit from 9.30am to 12.30pm and 2.30pm to 4.30pm on Monday, Wednesday and Friday, and from 10.15am to 12.30pm and 2.30pm to 4.30pm on Tuesday and Thursday during Criminal Trials and Appeals weeks.
- The Contracts Court sits every Tuesday and Thursday at 9.30am except for 29th March 2016 (Tuesday after Easter) and Tuesday 27th December 2016 (Public Holiday).
- There will be a sitting of the Full Court at 9.30am on Saturday 30th April, 2016 for the purpose of swearing in the Deputies of the States of Deliberation. No other business shall be listed for this Full Court.
- The Royal Court vacation, during which Court hearings will be kept to a minimum, will run from 1st August to 31st August 2016 inclusive (Criminal Division & Civil Division).
